The Treasurers report included the transfer of the funds of the Pension Defense fund. (\$15,618) A lengthily and spirited discussion took place and after all suggestions and recommendations were heard it was decided to vote on the idea of retaining those funds or Dispersing them. The vote was 6-0 to retain them and use them only for (Yet to be determined)

Pension Board Report Ken Buck Reported: There currently is 33.5 Billion dollars in the Pension Fund. There are about 52,300 persons collecting pensions from the PFRS fund. There has been No Change in the status of re-establishing COLA, The Pension Board COLA Committee has been meeting with Lawyers from outside and lawyers from with-in and they have been discussing Chapter 78 vs. Chapter 55 to no decision yet ! The dates of the next three meetings are Oct. 7; Nov. 4 & Dec. 9. The Meetings are held at 50 State Street Trenton, NJ.

Legislative Robert DelSordo Reported the Legislature is looking at up grading Robbery charges to a Class 3 offense because the Current Class 2 offense does not require Jail Time. He also stated Air travel will require REAL ID effective May 7th 2025. A New Jersey Driver Liscense with the Gold Star or Passport are acceptable forms of REAL ID.
